

The affiliating bodies shall not extend the affiliation to such institutions whose name is not appearing either in the common revised recognition order(s) or individual revised orders.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory, bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update its website as per provisions of NCTE Regulations and always display the following mandatory disclosure:-

Sanctioned programme(s) along with annual intake in the institution. (a)

Names of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale
